- 3) am aware of and understand the complexity of the Competition and acknowledge that I have sufficient technical knowledge and skills in running the declared distance of the Competition and that I am physically and mentally well-prepared for participation in the Competition;
- 4) am aware of the fact that my participation in the Competition may result in the adverse health consequences, and I shall be solely responsible for my own safety and health;
- 5) acknowledge, agree and declare that the Organizer shall not be liable for my death or injury and/or other damage to my health as a Participant of the Competition, loss or damage to my personal belongings, as well as any physical harm to me as a Participant of the Competition, occurred during the Competition, and I shall voluntarily and knowingly refuse from any material and other claims and demands towards the Organizer (its employees) and sponsors of the Competition. This refusal from the claims shall apply to my potential successors and caregivers and shall be valid before, during and after the Competition;
- 6) acknowledge that during the Competition I will, never and under no circumstances, intentionally create situations, which may cause damage in any form to other participants, the Organizer and sponsors of the Competition, unauthorized persons, as well as their property, and undertake to compensate for the damage caused;
